Executive Director's Report

Mr. Nagle gave an update on the Capital Projects that are underway, in the design phase or are in the planning phase.

Mr. Nagle said the electrical panel upgrade project at the Hauser Building is nearing completion.

The Hauser Roof Replacement project is nearly complete.

The window replacement project at Menotomy Manor is scheduled to go out to bid in the next few weeks.

Mr. Nagle is working with the designer and EOHLC project management to rebid the ventilation and fan upgrade project.

The Chapter 689-2 Special Needs home creation project is in the design phase along with the sewage ejector pump project at Chestnut Manor.

The parking lot repavement project at Drake Village is in the planning phase.

The Air Source Heat Pump project at the Hauser building is scheduled to begin in the next month or so.

The Senate released Senate Bill 2834 "An Act Relative to the Affordable Homes Act with a total of \$5.2 billion in capital authorizations." Within this bill are \$2 billion in authorizations for public housing modernization.

Mr. Nagle thanked Senator Friedman and her colleagues for their commitment to providing these funds for state public housing.

The Arlington Housing Authority has completed inspections at Chestnut Manor. Property Management is in the process of completing work orders and reinspections created by the inspections.

The Arlington Housing Authority met with Burgess Pest Management and Ms. Badilla again this past month to discuss the success of ongoing treatment methods. Burgess was able to showcase the decrease in the rat population.

The Arlington Housing Authority hosted its annual cookouts and celebrated its 75th anniversary at each of the Senior Housing Development is past month. We will celebrate our 75th anniversary with the residents of Menotomy Manor at National Night Out during the first week of August.

The Arlington Housing Authority participated in the Arlington Pride Event as a Community Partner on June 22^{nd} at the Town Hall.

The Arlington Center for the Arts has completed its programming for this year. They will be starting new programming in the fall.

Residents at Drake Village are participating in the creation of a mosaic and mural as part of the Creative Placemaking project. We plan to unveil this work sometime in the fall.

Cambridge Savings Bank is providing budgeting, credit, and scam training at each of our developments over the coming months.

Fidelity House continues to provide programming for Menotomy Manor residents.

Resident Services Coordinator, Tricia Horgan, as well as the property managers continue to work with residents to assist them in applying for rental assistance, utility assistance and other assistance.

The Arlington Housing Authority has hired a part-time Accounts Payable/Receivable Clerk, Lucille Capone

We are also currently in the process of hiring a new part-time Resident Services Coordinator. Karen Peterson left the AHA this past month for a full-time opportunity. Mr. Nagle wished her the best of luck and thanked her for all the work she has done for the residents over the past several months.

Ms. Preston wanted to know if there could be two full-time Resident Services Coordinators.

Mr. Nagle said he is looking into additional funding sources for it.
