Executive Director's Report

Mr. Nagle gave an update on the Capital Projects that are underway, in the design phase or are in the planning phase.

Mr. Nagle said that the Hauser Roof Replacement Project is complete.

The new transformer has been installed at Chestnut Manor. We are waiting for the next steps related to connecting the new transformer. The switchgear is estimated to arrive in January 2025.

Kneeland Construction has submitted the final items needing approval for the first-floor bathroom update project at Donnelly House.

Vareika Construction has been issued to Notice to Proceed for the Window Replacement and Envelope Repair Project at Menotomy Manor. The AHA will be working with them to schedule a meeting with residents once a schedule has been confirmed related to when materials will be available, and they are available to mobilize.

EOHLC has issued out the contract documents for the Ventilation and Fan Upgrade Project at the Hauser Building. We are waiting for the contractor, Thomas E. Snowden, Inc., to return the documents.

Chapter 689-2 Special Needs Home Creation Project is in the design phase.

The Sewage Ejector Pump Project at Chestnut Manor is in the design phase.

The Fire Alarm System Upgrade Project at Winslow Towers is moving into the design phase.

The Arlington Housing Authority held an unveiling for the Creative Placemaking Project's Mural and Mosaics this past month at Drake Village. Special thanks to the artists David Fichter, and Cecily Miller from the Arlington Commission for Arts and Culture as well as the residents and staff that helped create and install the murals and mosaics.

The Arlington Police Department will be providing AHA Maintenance Mechanic, Dennis Broughton, with a Certificate of Commendation to recognize the actions he took at Chestnut Manor to safeguard our residents.

The Holiday event at Menotomy Manor has been scheduled. We look forward to working with APD and AFD in bringing Santa back again this year.

Arlington Center for the Arts has started its programming at Winslow Towers, Chestnut Manor, and Cusack Terrace.

Mount Auburn has started Health Education Seminars at our Senior Developments.

The Arlington Police Department has started Fraud, Safety and Security Classes at our developments.

Fidelity House, Operation Success, and Family Access continue their programming at Menotomy Manor.

Knights of Columbus donated 155 coats for mothers and children at Menotomy Manor.

Mary's Cradle part of St. Vincent De Paul has started providing diapers at Menotomy Manor.
